# **Executive Summary**

# FZZA FIGHTING ONLINE

Founded in 2016, Gab Social markets itself as "the Home of Free Speech", an alternative to mainstream social media platforms such as Facebook and TikTok. The platform has attracted attention and criticism for its willfully laissez-faire approach to content moderation, particularly in relation to hate speech and antisemitism. This report scrutinizes Gab's role in facilitating antisemitic content, its terms of service, and the platform's role in spreading hate speech.

### **Key Findings**

- Promoting of Extremist Ideologies: Gab has become a breeding ground for far-right ideologies and antisemitic content. Unlike conventional social media platforms, Gab deliberately refuses to implement policies against hate speech, allowing the unrestricted dissemination and spread of extremist narratives.
- Lack of Content Moderation: Gab's terms of service clearly state that the site will not monitor hate speech, citing the First Amendment. Gab's lack of hate speech guidelines, by design, allows explicit antisemitic content to be posted without fear of challenge.
- Real-world Harm: Gab's lack of content moderation has directly contributed to real-world violence. The shooter responsible for the 2018 Pittsburgh synagogue attack used Gab to post antisemitic messages before carrying out that massacre.
- 4. Support for Antisemitic Groups: Gab's founder, Andrew Torba, has publicly endorsed antisemitic groups such as the Goyim Defense League (GDL). He has defended the presence of hate groups on the platform, framing it as a free speech issue while allowing their content to thrive.
- 5. Chatbots That Spread Hate: Gab has introduced multiple AI chatbots that promote conspiracy theories and extremist rhetoric, including Holocaust denial, and "great replacement" ideology. The "Talk to Adolf Hitler" chatbot actively denies the Holocaust, reinforcing neo-Nazi propaganda.
- Public and Legal Backlash: As antisemitic content on Gab continues to rise, there is increasing demand for regulatory intervention. However, Gab and its defenders argue that restricting the platform would constitute an attack on free speech.
- Lack of Action on Hate Speech Reports: Numerous reports of hate speech have been submitted to Gab, yet the platform has taken no action to remove this content. Gab explicitly states in its terms of service that it does not track or moderate hate speech.
- 8. The Spillover Effect of Deplatforming: The ban of the GDL on Telegram inadvertently resulted in a surge in antisemitic discourse on Gab. This shift highlights the limitations of isolated deplatforming efforts and the need for a comprehensive approach to combating online hate.

### Recommendations





**1. Monitoring and Regulation:** Regulatory bodies should conduct ongoing reviews and assess Gab's policies, to determine how they enable hate speech and contribute to real-world violence. Where necessary, legal frameworks should be updated to hold platforms accountable for fostering extremist content.



**2. Public Awareness:** Advocacy groups and researchers should continue monitoring and documenting antisemitic content on Gab to raise public awareness and build a case for necessary intervention.



**3.** Corporate Responsibility: Web hosting services, app providers, and financial platforms that facilitate Gab's operations should critically reassess their partnerships. Companies found to be enabling Gab negative activities should be scrutinized and urged to terminate services that indirectly support the proliferation of hate speech. Specifically, it appears that Gab may be using **Digital Ocean** (digitalocean.com) to host its site or online assets.[1]\_Hosting providers and related infrastructure services should be held accountable for their role in sustaining extremist platforms.



**4. Comprehensive Multi-Stakeholder Approach:** Governments, non-partisan regulatory agencies, civil society organizations, and technology companies must work together to implement proactive strategies that curb the spread of extremist content while upholding digital rights and security.

**In summary**, Gab's history of antisemitism is not merely a concern regarding online hate speech. It also poses tangible, real-world risks of violence that warrant immediate and coordinated action. Platform policies have led to a dangerous normalization of hate speech and extremist ideologies, calling for a coordinated campaign to address these issues.

The use of AI by Gab to disseminate antisemitism and anti-Zionist views raises additional profound ethical and societal concerns. It exemplifies how advanced technologies, when misapplied, can serve to bolster and spread extremist ideologies. The challenge this poses is not just about content moderation or the removal of offensive material; it also touches on the need for a deeper understanding of how AI can be harnessed by hate groups to automate and magnify their reach. This situation underscores the urgent necessity for comprehensive strategies that include both technological solutions and regulatory frameworks to address the misuse of AI in propagating hate speech and extremism online.

# Background

### FZZA FIGHTING ONLINE ANTISEMITISM

Gab is a social media network launched in 2016, conceived as a free speech alternative to popular social media platforms such as Twitter and Facebook. Gab was founded by software engineer Andrew Torba, acting on his belief that conservative viewpoints were being suppressed on other social networking sites[1].



In recent years, as social media networks have been criticized for failing to halt the spread of hate speech and false information, Gab, in particular, has drawn significant criticism over its handling of these issues. The platform has gained a reputation for its associations with far-right and extremist organizations[2], and some users have been caught encouraging antisemitism and hate speech[3].

Specifically, far-right and white nationalist groups leverage Gab to propagate their extremist ideologies, turning the platform into a breeding ground for antisemitic content. Users frequently upload and amplify content that slanders Jews and Jewish global domination.[4]

Unlike mainstream social media platforms, which have policies to remove hate speech and other harmful content, Gab does not have clear guidelines on what is considered permissible content[5]. Consequently, users can post explicit antisemitic content without fear of being banned or having their content removed.

# Gab's Terms of Service and Content Reporting Policy



Gab states in its terms of service that it applies the First Amendment of the U.S. Constitution to allow for fully unrestricted expression.[1]

Unlike conventional social media platforms such as Facebook, Twitter, and Google, Gab, in their terms of service, explicitly states that no actions will be taken against users who publish any type of hate speech[2]. Gab's policy allows all speech that is permitted by the First Amendment and disallows all speech that is not. Gab asserts that it will neither track hate speech nor provide any mechanism to report it, as it claims that the Constitution and federal law protect its right to do so.

According to Gab's website terms of service, the company declares that it will not take action against usergenerated hate speech content unless it is unlawful to the United States' First Amendment:

We will not be tracking "hate speech," providing any mechanism to report it specifically, nor responding to anyone who reports it because the Constitution and Federal law protect our right to do so and forbid New York from legislating otherwise")Gab users should anticipate no measures taken by the platform to remove hate speech content, as such content is considered lawful under the protections provided by the First Amendment.

If users wish to file a report for content which is objectionable they may do so with our moderation team via the usual channels. If they report conduct that is "hateful conduct" under New York law but which is lawful under the First Amendment they should expect that no action will be taken by us. We have the ability to respond to moderation reports but never do so[<u>3</u>].

Furthermore, Gab states that if users report conduct that is deemed hateful under New York law but is lawful under the First Amendment, they should expect no action to be taken by the platform[4].

# By Tolerating Hate Speech, Antisemitism Thrives on Gab



With such a laissez faire attitude relative to hate speech, Gab has become a home for antisemitic content. Antisemitism being tolerated on Gab has had far-reaching implications. The platform's promotion of racist content can normalize antisemitism and radicalize individuals already exposed to extremist ideologies. These developments have the potential to contribute to real-world harm, such as increased hate crimes and violence against Jews.

Gab's role as a platform for the distribution of antisemitic content gained attention in 2018 when it was revealed that the gunman of the **Pittsburgh synagogue shooting[1]** posted antisemitic messages on Gab before the attack. The platform was subsequently removed from the Apple and Google app stores, and multiple web hosting services terminated their agreements with the platform.

However, Gab continued its operations and has since attracted a user base consisting predominantly of right-wing and conservative individuals who believe that their views are unwelcome on other mainstream social media sites[2].

While Gab has been criticized for allowing hate speech and extremist content, its supporters argue that it provides a necessary outlet for free speech and serves as an alternative to the perceived bias of mainstream social media[3].



Due to the controversy surrounding Gab due to the prevalence of antisemitism, many are calling for increased regulation and moderation of the platform. Although Gab markets itself as a champion of free speech, the promotion of hateful content and extremist ideologies on the platform demonstrates that it is not a safe space for all users. Social media companies bear a responsibility to ensure that their platforms are not utilized to promote hate and extremism. Gab's association with antisemitism underscores the urgency for increased scrutiny and regulation of social media platforms.

In March 2022, FOA began monitoring Gab's platform. Despite regularly reporting instances of hate speech content to Gab, none of the reported content was removed. The chart below categorizes the content collected by FOA volunteers in relation to the the International Holocaust Remembrance Alliance (IHRA) working definition of antisemitism[1].

In January 2024, members of the FOA monitoring team discovered that Gab had begun blocking access from Israeli IP addresses. This development now requires the use of a VPN to access Gab from Israel. Blocking access from Israeli IP addresses prevents monitoring efforts and creates an echo chamber for antisemitic content.

On February 11, 2024, owner Andrew Torba responded to a Ynet publication by posting a status about this action to his personal Gab profile. "We were fed up with the p\*rn profiles, JIDF propagandists, and other subversive behavior that we've encountered over the years, all emanating from the same IP sources in the same country. It was time to end it, so we did," he said. (See screenshot of the post on the right).

# **AI Chatbots**





In January 2024 Gab introduced a controversial twist to the mainstream usage of artificial intelligence. It launched 91 new AI chatbots, a significant portion of which were found to propagate damaging ideologies, including Holocaust denial[1], anti-vaccination rhetoric, and support of efforts to confront the so-called "great replacement theory". Although certain profiles are clearly designated as parody accounts, the Hitler chatbots do not fall into this category. The Adolf Hitler chatbot continues to deny the Holocaust, echoing conspiracy theories and portraying its namesake as a victim of a supposed conspiracy.

Users can ask Gab AI characters. including Hitler, questions, but the responses, particularly those regarding Jews and the Final Solution, can be disturbing. This could fuel violent neo-Nazi ideology.

In January 2023, Andrew Torba, the CEO of Gab, shared his plans for the company's usage of Al in a post. In it, he urged Christians to join the Al race because mainstream Al tools have what he terms a "liberal/globalist/talmudic/satanic worldview." Torba promised to create a system that follows historical and biblical truth. He asked, "If the enemy is using Al for bad, shouldn't we make one for good?"

# Gab Image Generator- Empowering Hate Ideologies Through Image Generation



The Gab Al Image Generator allows users to easily create hateful images that they can spread easily. In this way too, Gab provides additional tools that have been used to generate antisemitic content directly through the platform's advanced capacities.




Image 2: The result of a request to the Gab AI Generator to create an image depicting a "Kill the Jews"



Separately, in March 2024, Gab's CEO implemented a new policy which may have the converse effect of curbing the volume of antisemitism on the site. Andrew Torba, announced that only paying users will be able to upload media, aiming to reduce storage space. "We will no longer be supporting free media uploads and hosting huge amounts of data for free[1]," Torba was quoted in February of that year. This decision sparked user outrage and calls to boycott. Despite criticisms, including claims of financial waste on Gab's unfiltered AI chatbot, Torba defended the profitability and market demand for Gab AI, indicating a potential shift towards a more insular, paid user base. This development may reduce the circulation of antisemitic and Holocaust denial images.

# Case Study: GDL - The Goyim Defence League. Illustrating a Hate Group Operating Unrestricted on Gab with Endorsement from Andrew Torba

To illustrate how extremist groups thrive on Gab, this section examines the activities of the Goyim Defense League (GDL), a far-right group that has found a home on the platform.

### About The Goyim Defense League (GDL): A Far-Right Extremist Group

The GDL, also known as the "Goyim Defense League," is a far-right extremist group based in the US that promotes white nationalist and neo-Nazi ideologies.

The group's core mission is to establish a white ethnic state across both Europe and the US, with a primary focus on defending non-Jewish populations ("Goyim") from what they perceive as a global Jewish conspiracy that controls major institutions. The organization was founded with the sole intention of dehumanizing and delegitimizing Jews. In a recent video posted on GoyimTV, members of the GDL can be seen spreading antisemitic flyers throughout a Jewish neighborhood in Palm Beach, Florida. The video is 4.5 hours long[2].

The GDL has come under significant criticism for its antisemitic and anti-immigrant rhetoric, which they spread primarily through social media platforms and by distributing flyers with hateful messages in residential areas across the US. However, their presence on these platforms has been short-lived, as in February 2023, Telegram banned the GDL channel for violating its terms of service.

FOA volunteers have noticed an increase in antisemitic comments on Gab's platform following the ban.

# Here are several examples of content that GDL has posted on Gab







In April 2023, Andrew Torba, the founder and CEO of Gab expressed his support of GDL antisemitic activity. Torba wrote about Governor Ron DeSantis of Florida who signed HB 269, a bill making it a felony to distribute "offensive" flyers or pamphlets, and HB 741, provisions on antisemitism. Both pieces of legislation have been criticized by Torba as violations of the First Amendment . Torba emphasizes that Gab supports the protection of free speech, engaging in open dialogue, and standing up against efforts to suppress open speech and dissent, regardless of political affiliations. The bills signed by DeSantis have elicited concerns from Torba about his commitment to upholding constitutional rights within the United States[1].
